## 2016 BILLING INFORMATION

### 1. Cancellation Policy

Bookings for groups of 8 or fewer players are required to provide a minimum of 48 hours notice of cancellation. Bookings for groups of 9 or more players are required to provide confirmation of number of players 7 days prior to the date reserved. A 10% reduction in the group size is allowed providing notification is provided a minimum of 48 hours prior to the first reserved tee time. Failure to provide sufficient notice of reduction of group size or a reduction of more than 10% of the confirmed number of players will result in charges based on the lesser of the number of players from the original booking or the number of players confirmed 7 days prior to the tee times. Upon cancellation of a group Sun Rivers will provide a cancellation number. Please ensure that you record this number.

### 2. Bookings

Tee times are subject to availability. A confirmation number will be provided at the time your reservations are confirmed.

### 3. Deposit

A deposit is not required from any Tour Operator in good standing with Sun Rivers. Sun Rivers reserves the right to impose a 10% deposit for group bookings with Tour Operators who fail to make payment or consistently pay outside of the 30 day terms.

### 4. Rates

Rates are based on the confirmed number of players in the group and the day and time in which they play. If the group size, day or time of play changes, the rate applicable to the revised booking will be charged. In the event that the group size changes less than 48 hours in advance of the first tee time, the rate will be based on the number of green fees that the Tour Operator will be charged for in accordance with the cancellation policy above.

### 5. Golf

Dress Code: All persons on the golf course are expected to dress in Preferred Attire. "Preferred Attire," means clean, presentable clothing in good condition and not offensive to other person using the Golf Course. Short shorts, cut-offs, bib overalls and tank tops are not acceptable attire. Sun Rivers is a soft spike only facility.

Equipment: Each player must have his/her own set of golf clubs and bag.

Pace of Play: Please respect your position with the groups ahead and behind you. The recommended pace of play is 4 hours 15 minutes to 4 hours and 30 minutes.

Number of Players: Five-somes or more will not be permitted without express permission from the pro shop staff. The course reserves the right to group twosomes together to form a complete group or add singles to groups.

Inclement Weather: Tournaments/Groups will play as scheduled unless Sun Rivers' management determines the course to be unplayable.

Language: Loud or profane language on the Golf Course or in the Clubhouse is expressly prohibited.

Power Carts: In the event that a participant has damaged a power cart used in the tournament, the convener (Host) will assume all responsibility for the repair of the cart.

Gratuities: There is an additional \$2.00 service charge per player for groups of 60 players or more.

### 6. Food & Beverage

All food and beverage consumed on the premises must be purchased through Sun Rivers. A cooler is provided on each cart to store beverages purchased from Sun Rivers. Any alcohol discovered will be confiscated and returned upon the completion of the round.

### 7. Insurance

Third party liability insurance for the benefit of the Host is strongly recommended for all Events. It can be purchased from your own broker or we would be happy to contact our broker for a quote on your own behalf.

### 8. Property Damage

Without restricting the generality of indemnification, the Host shall be responsible for all damages caused by the guests of the Event, the Host, it's agents or it's employees to Sun Rivers' Property or property of others.

#### 9. Waiver of Liability / Release

The Host agrees to release Sun Rivers, it's agents and employees, from any liability from personal injury, property damage or loss sustained by the Host directly or indirectly resulting from the Host's activities or participation in the contracted Event. The Host further waives, as against Sun Rivers, it's agents and employees, all claims recourses and rights of action that the Host might have against Sun Rivers as a result of such personal injury, property damage or loss.

#### 10. Indemnification

The Host agrees to indemnify, reimburse and hold harmless Sun Rivers, it's agents and employees, from and against any and all claims, demands, losses, costs, actions, suits or proceedings by Third Parties that arise out of or are attributable in any way to, the Event or the activities of the Host, it's guests, it's agents or employees or the use of Sun Rivers Property. In this section "cost" includes lawyer's fees (on a solicitor and own client basis), accounting fees and expenses, court costs and all other out-of-pocket expenses. Sun Rivers expressly does not waive its rights to any indemnity to which it may be entitled in addition to that stated above.

#### 11. General

The Host acknowledges that he/she has read these waiver, release and indemnity agreements and understands and accepts the contents hereof. The Host agrees that in the event that any provision herein contained is deemed to be unenforceable and/or invalid, that the provision shall be severable from the whole document and shall not affect the validity and enforce ability of the other provisions and documents as a whole.

The Tour Operator assumes responsibility for ensuring that the above rules are provided to the group members. Failure to abide by the above rules may result in the expulsion of the individual or group from Sun Rivers. Should an individual or group be removed from the premises the hotel remains responsible for payment in full according to the rate in effect for the group; regardless of the number of holes completed prior to being removed.
