1) Definitions

For this "Agreement" the following definitions apply:

- (a) "Green Fee" refers to one round (18 holes) of golf including colour GPS equipped power cart and practice facilities at Eagle Ranch Resort

2) Term

Commencing upon acceptance by the Partner and terminates on the closing date of golf operation at Eagle Ranch Resort for the 2016 season. Notwithstanding the above, the obligation of the Partner to pay for the Green Fees and interest thereon survives the termination of this "Agreement".

3) Golf Rates

Peak Season:

Net Partner rates are based on a 10 (%) discount off our Friday to Sunday & Holidays (**May 13 – September 29**) Rate of \$139.00 and a 20 (%) discount off our Monday to Thursday Rate of \$119.00 (**June 1 – September 18**).

Peak Shoulder Season (May 13 - 31, 2016):

Net Partner rates are based on 20 (%) discount off our Monday to Thursday Rate of \$109.00.

Early Shoulder Season (Open - May 12, 2016):

Net Partner rates are based on a 10 (%) discount off our Friday to Sunday & Holidays Rate of \$109.00 and a 20 (%) discount off our Monday to Thursday Rate of \$89.00.

Low Season:

Net Partner rates are based on a 10 (%) discount off our Friday to Sunday & Holidays (**Starting Friday September 30**) a Rate of \$109.00 and a 20 (%) discount off our Monday to Thursday (**Starting Monday September 19**) a Rate of \$89.00.

4) Payment

The Partner agrees to pay Green Fees for their client's actual golf day by supplying a corporate credit card or through payment of a monthly invoice from Eagle ranch Resort. Green Fees paid by invoice, must be paid within 14 days of invoice date. If a credit card is provided, the charges

will be processed on the day of play and a receipt will be faxed to the company with details of the charges. All Green Fees not paid for will be charged interest at the rate of 3% per month compounded monthly.
