PROCEDURES OF BOOKING

TO RESERVE TEE TIMES 8 DAYS OR MORE, IN ADVANCE

Northview G & CC will accept your voucher and invoice accordingly. The Club requires a non-refundable or non-transferable deposit of \$500.00 for groups over 12 people to secure your booking on a definite base. The deposit will be regarded as a down payment towards the total cost of the event. We also require 100% pre-payment, 7 days prior to day of play.

Rates stated are net rates. No further discounts will apply. **Rates are subject to change without notice.**

Northview G & CC will accept your voucher and invoice accordingly or we require 100% payment on the day of play.

BOOKING POLICIES

- Bookings within 7 days must be made through the Pro Shop (604) 576-4653
- Guaranteed number is due 7 days prior to day of play.
- Numbers may not decrease inside 7 days. You will be invoiced for the guaranteed or actual number of players, whichever is greater. We require 100% pre-payment, 7 days in advance to day of play based on your guaranteed numbers. In the event that payment has not been made within the above stated time frame, invoice balance will be applied to the credit card number on file.
- Numbers may increase if space is available.
- Northview reserves the right to fill incomplete foursomes

CANCELLATION POLICY

Cancellations must be made more than 7 days in advance by contacting Northview's Sales & Marketing office, without penalty. If the booking is cancelled within a week of the day of play, full payment will be taken based on guaranteed numbers.

GENERAL RULES OF PLAY

- Dress Code: Soft (non-metal) spikes are recommended. Appropriate golf attire is required; presentable, no ripped, soiled, vulgar or offensive clothing is not permitted. Golf or running shoes only, are acceptable foot wear on the golf course or in the Clubhouse.
- Guests will play as scheduled unless the Superintendent of Greens determines the course to be unplayable
- Each player must have a full set of clubs (Rentals are Available)
- No alcohol/coolers are permitted on the golf course. ie: beer in a cooler/bag. (Strictly enforced)
- Round duration is 4 ½ hours (maximum). Groups falling behind may be asked to pick up their ball and move to the next hole. (Strictly Enforced)
- Northview Golf & Country Club has a limited fleet of power carts. Unless pre-reserved, power carts and rental clubs are available on a 'first come, first served' basis. We reserve the right to restrict power cart usage at the discretion of the Golf Course Superintendent. Eg. Paths Only / 90° Rule.

RENTAL AGREEMENT

Any rental items (eg. Golf clubs, power carts, etc.) are hereby leased by the Club to the Lessee. If Lessee retains the said property after expiration thereof, such retention shall be construed as additional rental at the same rate of rental, and under the same terms and conditions as originally contained in this agreement. Said property is not to be removed from the golf course and is to be returned promptly to the Lessor after use. Lessee's custody and not to sublease or re-rent the same. Lessee agrees to keep said property in the same condition as when received. It is expressly understood and agreed, that no right of action whatsoever shall accrue to the Lessee for damages of any kind whatsoever, whether to person and/or property, and/or for loss of time and/or other loss or damage, arising from the use of, operation of, or in any way connected with, the said property or any part thereof, from whatever cause arising. Lessee agrees to hold all parties free and harmless from all such damage. Lessee expressly acknowledges personal liability to pay Lessor costs re repair all damages to said property and Lessor's costs including attorney fees incurred in collection of payments due from Lessee hereunder. The full agreement between the Lessor and Lessee is contained herein, and time is made of the essence of this agreement. The receipt of all above described property, in good order and repair is hereby acknowledged by Lessee.

NOT MORE THAN TWO PERSONS AND TWO GOLF BAGS SHALL BE IN ANY POWER CART AT ANY ONE TIME.

I hereby agree to pay for any damages that are sustained to the above equipment while in my/my client's possession, and I am totally familiar with the operation of same.
