



## 2017 Stewart Creek Partner Program “Incentive Pricing”

For the 2017 golf season, we would like to thank you for participating in our Golf Partnership Program. Through this program we endeavor to promote the business relationship between our companies with the goal of creating additional business for both Stewart Creek Golf & C.C. and your business. To attain this goal all partners must include Stewart Creek Golf and Country Club in their promotional media and advertising.

### **Booking Procedure**

Bookings can only be made in the following procedure after completing the Golf Partner Agreement form:

1. A Tee Time Request Form has been provided and must be used in the transaction of all bookings.
2. Bookings must be made by sending a fax of the tee time request to our reservation department at 403-609-6085.
3. If the requested tee time is available the reservations department will send back a confirmation fax with tee time confirmation number. The tee time is confirmed only upon receipt of the Stewart Creek Confirmation Fax. If the tee time is unavailable the reservations team will fax back a list of availability times that are close to the original request.
4. All information is required and must be received between Monday and Friday 8:30am to 5:00pm (MST). Bookings may be made beginning March 1, 2017.
5. All bookings of 13 or more players are considered Golf Events. These bookings will require completion of a Golf Event Application as well payment of a Golf Event deposit at the time of booking. Contact- John Munro at ([jmunro@scgolf.ca](mailto:jmunro@scgolf.ca))



### **Payment Procedure**

A valid Credit Card must be on file or \$5000.00 deposit provided.  
All Green Fees will be charged to your account on the day of play.

### **Guest Registration Procedure**

All guests should arrive at the facility 30 minutes prior to their tee time so that they can check in and warm up.

### **2017 Golf Rates**

A 2017 rate sheet has been provided complete with incentive pricing information. These rates may change from time to time based on the sole discretion of Stewart Creek Golf & C.C. These exclusive rates provided are for the 2017 season only and does not guarantee future rates. The partner rates are set rates and will not be adjusted to reflect any changes in public rates.

### **Golf Course Policy**

\*The **Cancellation Policy** for Stewart Creek Golf & C.C. is **48 hours**. Cancellations must be made prior to the two days by the Golf Partner and not the guest. Cancellations must be received by fax (only). If the tee time has been cancelled within the 2 days, the Golf Partner will be charged the applicable green fee rate.\*

The **Inclement Weather Policy** for Stewart Creek Golf & C.C. allows for rain checks or refunds to be issued. If the course is unplayable, a rain check will be issued for the guest. In the event that the guest is from outside of Canada and a rain check for play at a later date is not practical, a refund may be granted at the sole discretion of the Head Golf Professional. The refund will be applied to the account associated with the tee time booking.
