Partner Letter of Agreement

Between: Eagle Ranch Resort

And: BC Golf Guide

Eagle Ranch Resort agrees to sell Green Fees for the 2018 golf season subject to the terms and conditions that follow:

Definitions

For this "Agreement" the following definitions apply:

"Green Fee" refers to one round (18 or 9 holes) of golf including colour GPS, equipped power cart, practice facilities, two bottled waters per cart, ball washer and club washer.

Term

Commencing upon acceptance by the Partner and terminates on the closing date of golf operation at Eagle Ranch Resort for the 2018 golf season. Notwithstanding the above obligation of the Partner to pay for the Green Fees and interest thereon survives the termination of this "Agreement".

Payment

The Partner agrees to pay Green Fees for their client's actual golf day by supplying a corporate credit card that will remain on file until the 2018 golf season ends. Eagle Ranch will send you a detailed invoice monthly for approval and will process payment once approved. Please note that our terms are Net 15. If approval has not been given at this time, the invoice will be charged as sent and a receipt will be emailed to the Partner. *Please complete the credit card authorization form on the last page when returning the "Agreement". Should a company credit card not be available, please contact us to make other arrangements.*

Cancellation Policy

Groups of 1-11 players – Final numbers of players must be confirmed 72 hours prior to date of play

Groups of 12+ all changes to bookings must be made 7 days prior to date of play

Any changes made outside of the above stated cancellation policy will result in a charge for the number of guests booked prior to the times noted above.

Cancellation of Agreement

Eagle Ranch Resort reserves the right to immediately terminate this agreement if the Partner is not adhering to the Program Agreement, or for non-payment of Green Fees.

Verification of Bookings

Eagle Ranch Resort requires the Partner to provide their guest with a voucher stating the details of their golf booking. We ask that you provide us with a copy of this voucher template prior to any of your guests arriving so we know what we can expect to receive.
