Payment Procedure

All Green Fees will be charged to your account and the account will be reconciled with the credit card provided on the day of play.

Guest Registration Procedure

All guests should arrive at the facility 30 minutes prior to their tee time so that they can check in and warm up.

2018 Golf Rates

A 2018 rate sheet has been provided complete with incentive pricing information. These rates may change from time to time based on the sole discretion of Stewart Creek Golf & C.C. These exclusive rates provided are for the 2018 season only and does not guarantee future rates.

Golf Course Policy

*The **Cancellation Policy** for Stewart Creek Golf & C.C. is **48 hours**. Cancellations must be made prior to the two days by the Golf Partner and not the guest. Cancellations must be made online). If the tee time has been cancelled within the 2 days, the Golf Partner will be charged the applicable green fee rate.*

The **Inclement Weather Policy** for Stewart Creek Golf & C.C. allows for rain checks or refunds to be issued. If the course is unplayable, a rain check will be issued for the guest. In the event that the guest is from outside of Canada and a rain check for play at a later date is not practical, a refund may be granted at the sole discretion of the Head Golf Professional. The refund will be applied to the account associated with the tee time booking.

Booking Procedure

Bookings can only be made in the following procedure after completing the Golf Partner Agreement form. Partner code will be sent to Partner once agreement has been completed and returned.

1. Partner bookings of 12 players or less are to be booked online through the Stewart Creek website. The booking system will be available for Partner bookings starting March 1st, 2018.

1. Go to Stewart Creek homepage (www.stewartcreekgolf.com)
2. Click **Book a Time**
3. Enter tee time search parameters (date, requested time and # of players). Enter Partner code under Promo tab.
4. Click **Book** on desired time, if details are correct click **Add to Cart and Proceed to Checkout** and continue as a guest.
5. **On Billing and payment Information Screen:**
Enter Partner Code (as provided by Stewart Creek) under first name and clients name under last name. Complete remaining fields with partner billing information. Keep in mind that the booking system requires a credit card at the time of booking but it will not be billed. As per the contract, billing will occur on the day of play.
6. Click **Continue**. If details are correct **click Submit your Order**.

2. A few of key items to know when using the Partner code:

-  Partner discount available to bookings of 2 or more players
-  The partner code is only available through online bookings
-  Partner discount can only be applied to new bookings, if a client already has a tee time booked it will need to be cancelled and rebooked using the Partner code.

3. Although we recommend using the online system to book tee times, Partners can also call the reservations line at 403-609-6099 and speak with a golf course representative to make a booking. Partners must quote the Partner code at time of booking.
4. All bookings of 13 or more players are considered Golf Events. These bookings will require completion of a Golf Event Application as well payment of a Golf Event deposit at the time of booking. Contact- John Munro at (jmunro@scgolf.ca)
