



## Partner Letter of Agreement

**Between:** Silvertip Resort  
**And:** BC Golf Guide

Silvertip Resort agrees to sell Green Fees for the 2019 golf season subject to the terms and conditions that follow:

### 1) Definitions

For this "Agreement" the following definitions apply:

- a. "Green Fee" refers to one round (18 holes) of golf including colour GPS, equipped power cart, practice facilities, two bottled waters per cart, ball washer and club washer.

### 2) Term

Commencing upon acceptance by the Partner and terminates on the closing date of golf operation at Silvertip Resort for the 2019 golf season. Notwithstanding the above obligation of the Partner to pay for the Green Fees and interest thereon survives the termination of this "Agreement".

### 3) Golf Rates

Partner rates are based on a net rate of \$135.00 plus tax. Please note our regular fee for golf is \$175.00 plus tax.

Twilight partner rates will be available for the last 2 hour of play daily. Early Season partner rates will be available commencing opening day through till May 31<sup>st</sup>, 2019. The Early Season and Twilight Partner rate will be \$105.00 plus tax. Please note our regular rate for golf is \$135.00 plus tax.

### 4) Payment

The Partner agrees to pay Green Fees for their client's actual golf day by supplying a corporate credit card that will remain on file until the 2019 golf season ends. The charges will be processed at the end of each month and a receipt will be emailed to the Partner with details of the charges. *Please complete the credit card authorization form on the last page when returning the "Agreement".*
