



### **Letter of Agreement "Partner Agreement"**

**Between:** Eagle Ranch Resort ("Eagle Ranch")

**And:** BC Golf Guide ("BC Golf Guide")

Eagle Ranch agrees to sell Green Fees for the 2020 golf season subject to the following terms and conditions:

### **Definitions**

For this "Agreement" the following definitions apply:

**"Green Fee"** refers to the value as provided in the below Green Fee Grid for one round (18 or 9 holes) of golf, power cart, practice facilities, two bottled waters per cart, ball washer and club washer.

**"Caddie"** refers to the service now available upon request. Costs for this service are outside of the Green Fee and provided in the Caddie Fee below.

### **Payment**

BC Golf Guide agrees to pay Green Fees for their client's actual golf day by providing a completed and approved credit application. BC Golf Guide would be subject to pay, based on a detailed monthly invoice provided for approval by Eagle Ranch, and will process payment once approved noting payment terms are net 30 days. If approval has not been given within this time, the invoice will be deemed correct and a receipt will be emailed to the Partner to the attention of [danny@bcgolfguide.com](mailto:danny@bcgolfguide.com). *Please complete the credit card application form on the last page when returning the "Agreement". Should a company credit card not be available, please contact us to make other arrangements.*

### **Golf Booking Cancellation Policy**

Groups of 1-11 players – Final numbers of players must be confirmed with Eagle Ranch at least 72 hours prior to date of play.

Groups of 12+ all changes to bookings must be made at least 7 days prior to date of play

**\*Any changes made outside of the above stated cancellation policy will result in a charge for the number of guests booked prior to the times noted above.**

### **Verification of Bookings**

Eagle Ranch Resort requires BC Golf Guide to provide their guest with a voucher stating the details of their golf booking and would require to be provided with a copy of this voucher prior to any of your guests arriving. ### **Golf Rates**

Rates are based on a net rate paid on the applicable round being booked as shown in the grid below. Note that the rack rate shown is what all guests would pay. BC Golf Guide's amount is based on it charging this rate to the guest. We ask that you do not exceed the posted rates when charging your



guests. We also ask that these rates are offered to you in confidence and are not to be shared or disclosed without the consent of Eagle Ranch.

Single Bag	\$90/pp + gratuity
Double Bag	\$85/pp + gratuity
Forecaddie	\$90 minimum or \$30/pp for a group of 4 + gratuity

**\*Please note that Caddies must be pre-booked at least 48 hours in advance. Cancellation of services must be made no later than 24 hours prior to tee time. Failure to cancel with sufficient notice will result in the charge of the fee(s) earlier booked.**

#### **Term and Termination**



The Term will commence upon acceptance by the partner and terminating on the closing date of golf operation at Eagle Ranch for the 2020 golf season. Notwithstanding the above obligation of BC Golf Guide to pay for the Green Fees and interest thereon survives the termination of this "Agreement". Eagle Ranch reserves the right to terminate this arrangement if KVR is unable to adhere to the Terms, or for non-payment of Green Fees.
