Partner Letter of Agreement

2020 Golf Season

Between: Tower Ranch GC
And: BC Golf Guide and Golf Kelowna
For: Partner Tee Time Booking Program

Tower Ranch GC agrees to sell Green Fees for the 2020 golf season to the Partner names above subject to the terms and conditions that follow:

1) Definitions For this “Agreement” the following definitions apply: (a) “Green Fee” refers to one round (18 holes) of golf cart at Tower Ranch GC

2) Term Commencing upon acceptance by the Partner and terminates on the closing date of golf operation at Tower Ranch GC for the 2020 season. Notwithstanding the above, the obligation of the Partner to pay for the Green Fees and interest thereon survives the termination of this “Agreement”. Net rates will be utilized in the creation of golf packages and that under no circumstances will our net rates be disclosed to the public. We encourage you to package additional rounds whenever possible (ie. One night – two rounds packages. Two nights – three rounds package etc.).

3) Golf Rates PEAK SEASON (May 1st – September 30th) Friday to Sunday and Holidays; Net Partner rates receive a \$25.00 discount off (or \$114 rate) prior to 1pm and a \$35.00 discount off (or \$104 rate) after 1pm.

Monday to Thursday (excluding Holidays); Net Partner rates receive a \$25.00 discount off (or \$104 rate) prior to 1pm and a \$35.00 discount off (or \$94 rate) after 1pm. Please see attached rate sheets for further clarification.

SHOULDER SEASON (Open to April 30th – all of October) Friday to Sunday and Holidays; Net Partner rates receive a \$15.00 to \$45.00 discount off (or \$94 rate) all days.

Monday to Thursday (excluding Holidays); Net Partner rates receive a \$15.00 to \$45.00 discount off (or \$74 rate) all day. Please see attached rate sheets for further clarification.

4) Payment: The Partner agrees to pay Green Fees for their client’s actual golf day by supplying a corporate credit card. The charges will be processed by credit card by the 15th of each month. All Green Fees not paid for will be charged interest at the rate of 1% per month compounded monthly.
