2023 GOLF NET RATES: Valid April 1 to October 31

Golf Conditions:

Frost, fog or inclement weather may cause delay of tee times. If playing conditions require cancellation of the event, to be determined by the Course Superintendent, prior to the first tee time a full refund will be issued. Should a rain out or course closure occurs, to be determined by the Course Superintendent, during the round, the Director of Golf will make an equitable adjustment to the charge.

- **Booking of tee times must be completed via email: proshop@bearmtn.ca**
- Golf net rates are listed per person and **include GPS on power carts, range balls & bottled water.**
- Must book groups of 2 or more, singles may only be booked and confirmed 1 day in advance.
- Golf rates are quoted in Canadian Funds, and are net, non-commissionable and are subject to applicable taxes (Green Fee- GST 5% Cart- GST 5% PST 7%). All pricing is confidential.
- Each player must have a set of golf clubs. Rental clubs available for \$75 plus taxes and includes two sleeves of balls. Only two players and two golf bags are allowed per power cart.
- Each player requires a valid drivers license to operate a power cart.
- Vendor must provide client with a uniquely numbered voucher indicating date, time and number of golfers to be presented at time of check-in. Failure to present voucher will result in prevailing green fee charged to guest unless otherwise arranged.

Golf Cancellation Policy:

- Any tee-time cancellations must be received 24 hours prior to arrival time, otherwise full fees and taxes will be charged.

Course Closures:

Please note that courses may be subject to various closures for course maintenance and agronomic practices. The current tentative schedule for **2023** Aeration is as follows but subject to change

Mountain Course:

Closed: April 17-20

Closed: September 25-28

Valley Course:

Closed: April 3-6

Closed: October 2-5

Insurance & Indemnification: The Resort and Company each agree to carry adequate personal property, liability and other insurance protecting it against any claims arising from any activities conducted in the Resort or while on the golf course during the guests stay. Each party hereby indemnifies and holds the other harmless from any loss, liability, costs or damages arising from actual or threatened claims or causes of action resulting from the gross negligence or intentional misconduct of such party or its respective officers, directors, employees, agents, contractors, members or participants (as applicable).

Impossibility: The performance of this Agreement is subject to termination without liability upon the occurrence of any circumstance beyond the control of either party – such as acts of God, war, acts of terrorism, government regulations, disaster, strikes, civil disorder, or curtailment of transportation facilities – to the extent that such circumstance makes it illegal or impossible for the Bear Mountain Resort to provide, or for the Group in general to use, the venue.

Damage to Equipment: The company acknowledges and agrees that operating a golf cart or golf equipment is dangerous and involves risk of serious bodily injury and/or property damage. The company, on behalf of itself, its participants and associates, expressly acknowledges that no person under the age of sixteen (16) years of age and without a valid driver's license, will operate a cart and that all participants and associates will have the capability to and will operate the golf cart at all times in a safe and responsible manner. The company will be liable for any and all damage to equipment, property and or persons due to negligence or otherwise, including but not limited to the downtime of the equipment if required to be sent off property for repair. Such damages will be charged to the companies account and included in the final billing to the Group.
