This Agreement is between the Gallagher's Canyon Golf Club and BC Golf Guide that sets forth the Terms and Conditions by which BC Golf Guide will conduct its Golf bookings during the 2022 Season. Thank you for participating in the Gallagher's Canyon Golf Club 2023 Net Rate Program. We look forward to working with you to create great golf vacations for your clients.

Terms and Conditions

1. All Net Rates include Green Fee, shared Power Cart, and full use of the Practice Facility. Net Rates apply to the full daily Green Fee as per the attached rate sheet. Net Rates are not applicable on matinee, twilight, or dinner special green fees. Club rentals are not applicable to Net Rates and payment is required from your Guest at time of Check-In. Payment of Net Rate bookings is due upon receipt of invoice.
2. Net Rates are applicable for any group size.
3. Individual Bookings:
1-15 players can be booked through email and or phone reservation and are guaranteed by this contract, with a 48-hour cancellation policy being applicable. Please supply your Guests with a voucher to present at the time of check-in. Clients without a voucher will be charged the applicable Net Rate and all efforts will be made by BC Golf Guide to forward a valid voucher to Gallagher's Canyon at your earliest convenience.

4. Singles Policy:

The golf course cannot guarantee that singles, twosomes or threesomes will play alone unless the entire Tee-Time is purchased (4 players). The course reserves the right to match incomplete foursomes with other players and may move a Tee-Time within 30 minutes to complete a foursome.

5. Cancellations and Liability for 1-15 Golfers –

If a cancellation is made more than 48 hours prior to a Tee-Time, Gallagher's Canyon Golf Club will issue a cancellation number. It is the responsibility of BC Golf Guide to request and record the cancellation number. If a booking is cancelled within 48 hours* **or** your guest is a "No Show" **or** a cancellation number is not provided, **BC Golf Guide** will be liable for the payment of the booking at the applicable *Net Rate*. This policy is strictly enforced.

6. Aeration:

It is the responsibility of **BC Golf Guide** to notify guests about aeration of the course, dates to be provided by Gallagher's Canyon Golf Club. Notification will be monitored at time of check-in. If a guest has not been made aware of aeration **BC Golf Guide** will be responsible for 50% of the value of certificates given as compensation for aeration inconvenience. **2023 aeration dates are tentatively set for N/A.**

7. Group Bookings (16 or more Players):

Preferred Partner Net Rates are applicable for any size consecutive Tee Time groups of 16 or more players and can be booked through email and or phone reservation and are guaranteed by this contract. A 5-Day cancellation policy being applicable on Groups of 16 or more Players. Please supply your Guests with a voucher to present at the time of check-in. Clients without a voucher will be charged the applicable *Net Rate* and all efforts will be made by **BC Golf Guide** to forward a valid voucher to Gallagher's Canyon at your earliest convenience. Should Groups require additional Food and Beverage requirements, please contact our Group Coordinator.

Payment of Net Rate bookings is due upon receipt of your monthly Invoice, and not later than 15 days from the date of play. Late payments will be subject to interest charges. A Credit Card will be held on file to guarantee all amounts due to the courses. Failure to pay within our terms could result in cancellation of your contract without notice resulting in the loss of Net Rates and/or booking privileges.

9. No posting or advertising of individual golf rates lower than the course's posted rack rate will be allowed.
