



2024 OKANAGAN GOLF CLUB NET RATE CONTRACT

This Agreement is between the Okanagan Golf Club and BCGolfguide.com / Golf Kelowna hereinafter: "Tour Operator") that sets forth the Terms and Conditions by which the Tour Operator will conduct its golf bookings during the 2024 Season. Thank you for participating in the Okanagan Golf Club 2024 Net Rate Program. We look forward to working with you to create great golf vacations for your clients.

Terms and Conditions

1. All net rates include green fee, shared power cart, and a warm-up basket of balls for the practice facility. Net rates apply to the full daily green fee & double round greens listed below. Net Rates are not applicable on twilight, sunset, or any special green fees.
2. Club rentals are not applicable to net rates (payment is required from your guest at time of check-in).
3. Net Rates are applicable for any size group. For groups of 16 or more players and prepayment may be requested.
4. Singles Policy: The golf course cannot guarantee that singles, twosomes or threesomes will play alone unless the whole tee-time is purchased (4 players). The course reserves the right to match incomplete foursomes with other players.
5. Cancellations and Liability
 - i.i. If a cancellation is made more than 48 hours prior to a tee-time, Okanagan Golf Club will issue a cancellation number if required. It is the responsibility of the **Tour Operator** to request and record the cancellation number.
 - i.ii. If a booking is cancelled within 48 hours* or your guest is a "no show" or a cancellation number is not provided, the **Tour Operator** will be liable for the payment of the booking at the net rate. This policy is strictly enforced.
6. Aeration:
It is the responsibility of the **Tour Operator** to notify guests about aeration of the course, dates to be provided by Okanagan Golf Club. Notification will be monitored at time of check-in. If a guest has not been made aware of aeration the **Tour Operator** will be responsible for 50% of the value of certificates given as compensation for aeration inconvenience.
7. Payment Terms: Payment of net rate bookings is due upon receipt of invoice, and not later than 30 days from the date of play. Late payments will be subject to interest charges. A credit card will be held on file to guarantee all amounts due to the courses. Failure to pay within our terms could result in cancellation of your contract without notice resulting in the loss of net rates and/or booking privileges.
8. Credit Application: A valid credit card number must be submitted with the below form by email for us to update all contact information and activate/re-activate your account.
9. No posting or advertising of individual golf rates lower than the course's posted rack rate will be allowed.
10. Please include a copy of the voucher you will be providing to your guest, if applicable.
