

# 2024 PARTNER NET RATE TERMS & CONDITIONS



## ADDITIONAL RATES

### 1. Replay Rates

Replay rounds are based on availability and should be booked in advance. Replay rates are non-commissionable.

**April, May & October** - \$69 per person + GST (cart included).

**June - September** - \$79 per person + GST (cart included).

### 2. Junior Rates - 19yrs and under

All juniors must be booked directly with Big Sky by calling the golf shop. Rates are non-commissionable. Juniors 16 and under must be accompanied by adult.

### 3. Single Players

Single players can be booked online. Rates are commissionable. Note the net rate cart fee for single players is \$34 plus GST & PST. A surcharge of \$10 plus taxes will be billed to your account at check-in by the golfshop for the single power cart fee.

## TERMS & CONDITIONS

### 1. Green Fees

All green fees include a shared power cart, and are subject to applicable taxes. Twilight tee-times are available to book but are non-commissionable. Rental equipment is not included in the posted net rates. Guest can pay for these at check-in.

### 2. Individual Bookings (less than 12 players)

1-11 players must be booked online via Big Sky's website. A confirmation number will be issued once the booking is complete - keep this number for your records.

Add any special requirements or comments in the Notes field when booking and ensure the proper reseller code is being used at the time of booking. The rates attached to the reseller code used at time of booking are the rates that will be charged. No refunds or adjustments will be made for rounds already played.

The golf course cannot guarantee that singles, twosomes or threesomes will play alone unless the whole tee-time is purchased (4 players). The course reserves the right to match incomplete foursomes with other players and may move a tee-time within 30 minutes to complete a foursome.

## 3. Group Bookings (12 or more players).

Net Rates are available for any consecutive tee time groups of 12 or more players but must be arranged via email with Big Sky's group booking contact. A group event contract must be signed and returned to confirm booking. Shotgun rates are available - please email for details. Groups are subject to a \$3 bag handling fee per person + GST. 21 - 30 day cancellation policy dependent on group size/contract.

Request for additional group services (personalized cart plates, hole contests etc.) must be received via email at least 7 days prior to the tee time.

## 4. Cancellations and Liability

A cancellation number will be issued once the booking has been successfully cancelled - keep this number for your records. If a booking is cancelled after the cancellation period (see below), the guest is a "no show", or a cancellation number is not provided, **the partner will be liable for the payment of the booking at the booked rate. This policy is strictly enforced.**

### Cancellations for 1-11 Golfers

Any cancellations must be made online via Big Sky's website, or in writing via email at least 48 hours prior to the tee time.

### Cancellations for groups 12 or more

Any cancellations must be made 21 days (12 - 68 players) - 30 days (72 - 144 players) prior to the date of play or charges will apply. An email confirming the cancellation will be sent including the cancellation number once the booking has been successfully cancelled.

If there are internet or connection problems, the cancellation must be made in writing by email to the golf course directly; an acknowledgement of cancellation will be issued in return. It is the responsibility of the partner to submit cancellation requests and keep record of the cancellation number to ensure that charges are not applied. Refunds or adjustments requested without a cancellation number will be denied.

## 5. Payment Terms

**INVOICES WILL BE PROVIDED AND AMOUNTS ARE DUE DIRECTLY TO BIG SKY GOLF INC.** Payment is due within 15 days of invoice date. Late payments will be subject to interest charges. A credit card will be held on file to guarantee all amounts due to the golf course and will be used in the event payment is not made in a timely manner. Failure to pay within our terms could result in cancellation of your contract without notice resulting in the loss of net rates and/or booking privileges.

## 6. Taxes

All rates are quoted in Canadian funds and subject to applicable taxes. Taxes are subject to change without notice.

## 7. Guests Paying Directly

Reservations made for guests who are paying directly must be made via telephone or email, and MAY NOT be made online. Net rates are not applicable - full rack rates at the time of play will apply. The guests' credit card number, phone number, postal or zip code and email must be provided at time of booking and it is the responsibility of the partner to inform the guest of our 48 hour cancellation policy and dress code.

## 8. Marketing

You can find our Big Sky Logo and up-to-date high resolution images for your personal marketing at the link below. No posting or advertising of individual golf rates and/or posting or advertising of golf rates lower than the courses rack rate will be allowed. Any advertising that competes with the golf course will result in revocation of contract rates and/or programs.

## 9. Speed of Play

Big Sky Golf Club targets 4 hours and 20 minutes for 18 holes of golf with tee times spaced at 10 minute intervals. Please advise your golfers that a golf course marshal will enforce speed of play for all players. Players unable to keep pace will be managed until they recover their original position at the start of play.

## 10. Golf Dress Code and Footwear Policy

All golfers are required to adhere to and follow these standards. Collared shirt required; Denim jeans, jogging pants and cut-off shorts are prohibited. Soft spiked golf shoes, cross-training shoes & other athletic footwear allowed. Use of metal spiked golf shoes are prohibited.

## 11. Alcohol

Guests are not permitted to bring their own alcohol anywhere onto Big Sky's premises. Any personal alcohol will be confiscated. **Beverages** are available to purchase from the restaurant and the **beverage cart**.

## 12. Agreement

The contract must be completed and returned in order for us to update all information and activate/reactivate your account. Net rates and the contract will be sent separately in an email.
