



2024 Stewart Creek Partner Program- BC Golf Guide “Incentive Pricing”

For the 2024 golf season, we would like to thank you for participating in our Golf Partnership Program. Through this program we endeavor to promote the business relationship between our companies with the goal of creating additional business for both Stewart Creek Golf and Country Club and your business. To attain this goal all partners must include Stewart Creek Golf & C.C in their promotional media and advertising.

2024 Golf Rates

A 2024 rate sheet has been provided complete with incentive pricing information. These rates may change from time to time based on the sole discretion of Stewart Creek Golf & C.C. These exclusive rates provided are for the 2024 season only and does not guarantee future rates.

Payment Procedure

Stewart Creek will create an account under BC Golf Guide and a valid Credit Card must be kept on file. This account will be billed the applicable rate on the day of play when guest check-in. Accounts will be settled monthly by charging the credit card on file and a monthly statement will be sent out detailing all transactions (Please check immediately and contact us directly regarding any queries or discrepancies). A \$1000 deposit will be required to gain access to the booking portal and partner incentive rate. This deposit will be refunded back to the partner at the end of the season when the account has been settled or may be carried forward to the following season.

Golf Course Policy

*The **Cancellation Policy** for Stewart Creek Golf & C.C. is **48 hours**. Cancellations must be made prior to the two days by the Golf Partner and not the guest. If the tee time has been cancelled within the 2 days, the Golf Partner will be charged the applicable green fee rate.* All cancellations must be done through the online booking system

The **Inclement Weather Policy** for Stewart Creek Golf & C.C. allows for rain checks or refunds to be issued. If the course is unplayable, a rain check will be issued for the guest. In the event that the guest is from outside of Canada and a rain check for play at a later date is not practical, a refund may be granted at the sole discretion of the Head Golf Professional. The refund will be applied to the account associated with the tee time booking.



Guest Registration Procedure

All guests should arrive at the facility 30 minutes prior to their tee time so that they can check in and warm up.

Booking Procedure

Bookings can only be made in the following procedure after completing the Golf Partner Agreement form. Once the partner agreement is signed and returned with the \$1000 deposit processed, a username and password will be supplied.

This platform allows the partner to:

- ❖ See all available bookings in the tee-sheet.
- ❖ See your rate (No promo code required).
- ❖ Book at your convenience.
- ❖ Add a guest name.
- ❖ Add notes if required.
- ❖ You can see all your bookings in the tee-sheet (as a list and as a tee-sheet).
- ❖ You can manage your bookings in the tee-sheet (i.e cancel/re-schedule).

Detailed instructions on the booking process will be supplied in a separate document along with login and password information.

Cancelling bookings is the responsibility of the partner through the online account, detailed instructions will be supplied in a separate document.

Group Booking Procedure

Stewart Creek Golf & C.C. agrees to sell a regular Green Fee for the 2024 season at a special incentive price to the Golf Partner subject to the following terms and conditions as outlined below:

- a. Definition: "Green Fee" is defined as one (1) round of 18 holes of golf including power cart and driving range.
- b. Payment: A monthly statement will be sent out detailing all transactions. (Please check immediately and contact us directly regarding any queries or discrepancies). Payments will be processed on the 8th of each month to the credit card on file. All payments will incur a 2% credit card processing fee. Please ensure sufficient funds are available for payment.
- c. Deposit: A \$1000 deposit must be provided at the time of signing the partner agreement and to access partner booking details. This amount will be refunded at the end of the season once all accounts have been settled or may be carried over to the following season.
- d. Golf Rates: The Golf Rates have been listed on the Incentive Pricing Program form contained within this package.
- e. Term: The term of this agreement commences at the time this agreement is accepted by Stewart Creek Golf & C.C. and runs through until October 31, 2024.
- f. Cancellation: Stewart Creek Golf & C.C. reserves the right to cancel this agreement at any time if the Golf Partner does not adhere to the program as defined.
