**TOUR OPERATOR AGREEMENT  
2025 Golf and Summer Lift Season**

**Sun Peaks Summer Season Ending October 5, 2025**

This **AGREEMENT** dated **September 13, 2024** is between:

**Sun Peaks Resort LLP** ("SPR LLP")

AND **BCGolfGuide.com** ("Tour Operator")

The following agreement is prepared for BCGolfGuide.com for the 2025 golf and summer lift season.

**BACKGROUND**

- A.** SPR LLP is the owner and operator of Sun Peaks Resort and related facilities;
- A)** The Tour Operator will sell rounds of Golf, Biking and Hiking Lift Tickets, E-Bike Rentals, and RV Parking at Sun Peaks Resort.

**B. TERMS AND CONDITIONS**

For good and valuable consideration, the receipt and sufficiency of which each party acknowledges the parties agree as follow:

**1. General Information.**

The wholesale golf rates given by SPR LLP are applicable to all pre-booked golf rounds. SPR LLP wholesale rates are for FIT bookings only and can be booked for groups of up to 20 people. Tournaments and groups of 20 or more are not commissionable and must be booked direct. All prices are in Canadian dollars. The Tour Operator is responsible for booking a tee time on behalf of their guests. Lift rates are net/non-commissionable wholesale rates and are available on a pre-booked, pre-paid basis. Orders that have not been previously requested will not be honored at the contract price, but at the full retail price. The following information within this contract is considered to be confidential.

**2. Provisions of Program.**

Provided that the Tour Operator is not in default of the terms of this Agreement, SPR LLP agrees to provide golf rates and lift rates to the Tour Operator for the 2025 summer golf and lift season. (see Exhibit A for season dates)

**3. Confirmation.**

Tee times for all guest excursions may be emailed to [lfine@sunpeaksresort.com](mailto:lfine@sunpeaksresort.com) and must be received a minimum of seven days prior to their arrival. Info pertaining to lift tickets must be emailed to [tourops@sunpeaksresort.com](mailto:tourops@sunpeaksresort.com) a minimum of seven days prior to guest arrival. SPR LLP will email back a confirmation.



**4. Cancellation Policy.**

SPR LLP requires 48 hours' notice before guest arrival, for all cancellations, otherwise the green fees and lift tickets will be invoiced and deemed non-refundable. Policy for cancellations inside 24 hours includes injuries that render the person incapable of playing golf or using their lift ticket, complete course closure, or complete mountain closure. Rain does not constitute course or mountain closure.

**5. Golf and Lift Ticket Rates.**

As outlined in Exhibit A. Please note that all rates provided are subject to applicable government taxes. Prices are per person, per 18-hole round (Golf), or per day for lift tickets (Bike and Hike) and in Canadian funds. Each offer is exclusive of the others and cannot be combined and is subject to change.

**6. Payment for Lift Tickets/Golf Rounds/Rentals/RV Parking.**

Payment is required on the 15<sup>th</sup> day after the invoice has been issued. Any discrepancy in the invoice must be raised in writing with SPR LLP Accounting Department prior to the payment deadline or the invoice will be deemed to have been accepted by the Tour Operator.

**7. Failure to Pay.**

If payment in full for an invoice is not received or postmarked by the due date, late invoices will be subject to a daily interest charge of 28.00% per annum on the invoiced amount. Interest will be calculated on the number of days late. SPR LLP may also elect to stop honoring golf round bookings by the Tour Operator until all outstanding amounts have been paid in full. If there are repeat late payments, SPR LLP reserves the right in its sole discretion to cancel this Agreement with the loss of the rights to the program.

**8. Credit Card Pre-Authorization.**

The Tour Operator will provide a credit card to be charged in the event of a payment being 15 days overdue.

By signing this agreement, the Tour Operator authorizes SPR LLP to charge a provided credit card for any lift tickets or golf rounds ordered by the Tour Operator and fulfilled by SPR LLP for which payment is overdue by 15 or more days at the net rates outlined in Exhibit A.

**9. Availability of Product.**

If there is any outstanding account balance owing to SPR LLP in respect of golf rounds, or lift tickets from the current or previous year by the Tour Operator, that outstanding balance must be paid in full prior to continued participation in the Tour Program for the current year or prior to any further golf rounds being made available to the Tour Operator.



**10. Rules.**

In order to regulate the proper use of the Tour Program, SPR LLP may from time to time publicize reasonable rules and regulations with respect to the program. If the Tour Operator is in breach of any of the rules or regulations, SPR LLP in its sole discretion may terminate this Agreement.

**11. Compliance.**

The Tour Operator agrees to comply with and be bound by the rules and conditions of this Agreement.

**12. Damages.**

If the lift tickets or golf rounds issued by the Tour Operator are released, distributed or sold to the consumer other than in connection with packages made available to the consumer and/or travel agents, such event shall be a fundamental breach of this Agreement and the Tour Operator agrees to indemnify and save harmless SPR LLP from all loss, costs, and damages suffered or incurred as a result of that breach including, without limitation, loss of revenue.

**13. Insurance.**

The Tour Operator agrees to provide SPR LLP, prior to redeeming or using any tickets or Vouchers, with a certificate of insurance that names 'Sun Peaks Resort LLP', its directors, officers, employees, agents, contractors, representatives, and His Majesty the King in right to of the Province of British Columbia as an additional insured on their insurance policy and such policy will carry a minimum of \$10 million in liability.
