2025 Net Provider Agreement

1. Booking Procedures – Reservations for groups of up to 12 players may be made over the phone with our pro shop at (250) 478-4653. Book using the name of your company, - _____, and provide the first and last name of the persons the reservation will be for. If you know of any club rental needs, please let us know at this time. Groups of over 16 players may play after 11:00 a.m. and must be made with Jeff Palmer at 250-478-4653 ext. 106 or by email at jeff@highlandpacificgolf.com.
2. Cancellation Policy – You must provide at least 48 hours of notice for a cancellation with no charge. “No-shows” will be billed at the full rate. Rain cheques are issued under certain circumstances, and will be discussed directly with the net provider representative.
3. Accounts – A credit card must be provided to secure your account. Account invoices and/or statements will be sent monthly to the e-mail address we have on file. Accounts must be cleared within 30 days of receipt of invoice.
4. Course Maintenance – Aeration of our golf course are currently scheduled **for between April 1st & 10th, 2024 and September 16th and 23rd, 2025**. Reduced rates may be in effect. Final dates are “to be confirmed”. Contact Jeff Palmer for more information at jeff@highlandpacificgolf.com.
5. Rates – Our net rates are provided on the following page. Net wholesale rates cannot be disclosed to the public. Please note the weekend rate starts on Friday and on long weekends the weekend rate will be charged on the holiday Monday.
