

2012 Wholesale FIT & Tour Group Contract

Reservation Conditions

- The Inn must receive rooming lists for multiple room reservations no less than thirty (30) days prior to date of arrival.
- The Inn does not guarantee connecting or adjoining room combinations, but will make every attempt to accommodate
- Unless the said company submits a written guarantee to cover guest incidentals guests need to provide a credit card and are responsible for all their incidentals.
- Room availability may be verified over the telephone, however, no reservations will be made until a email or fax request for reservation is received and confirmation provided

Deposit Policies

- Deposits for each group are assessed based on the actual number of rooms blocked and the number of room nights
- For those granted direct billing privileges a faxed copy of an authorized credit card will be required to ensure our ability to obtain deposits by the dates required.
- Full payment of all tour group rooms blocked will be required to secure your room blocking if another party requests a booking for the same dates and will confirm with full payment prior to 60 days

Cancellation Policies

Group Policy

All cancellations must be emailed to groups@stigr.com or faxed to (250) 573-2853 in order to confirm cancellation

- Cancellations received less than 30 days prior to arrival will result in full penalty based on the number of rooms blocked for the duration of the dates agreed upon
- Note: the same cancellation policy applies in the event the agreed upon length of stay is reduced
- Should we manage to resell your cancelled room block, an adjustment will be made to the cancellation fee to reflect this

FIT Cancellations

- All cancellations must be emailed to groups@stigr.com or stay@stigr.com or faxed to (250) 573-2853 in order to confirm cancellation
- Proof of cancellation will be a faxed copy of the cancellation request signed and dated either by the Group Coordinator or members of management (In FIT situations by the Front Desk Agent)
- Cancellations received less than 48 hours prior will result in full penalty.

In the unfortunate event that it becomes necessary for you to cancel your room blocking with us, we would be in a difficult position to try to resell your room nights and would, no doubt, result in additional loss of revenue for the Inn. We will however, attempt to resell the room nights that were reserved for your group and would only assess a cancellation fee for those room nights not resold over the initially agreed upon dates. This fee would be based upon the unsold room nights multiplied by your established group rate for that period.

In the event of a national emergency or an act of God, cancellation policies will be null and void.
