Rates are quoted in Canadian funds and are per room, per night based on single/double occupancy for Standard Parkview guestrooms. Additional adults in the same room are \$15.00 per person, per night plus applicable taxes. Parking is \$5.00 per day per vehicle plus applicable taxes. Children 16 and under are complimentary when staying with their parents.

The above room rates are subject to availability. You must call the hotel directly for room availability as some blackout dates are already determined and other blackout dates are being entered on a daily basis. Cancellations must be made with no less than 72 hours notice for all FIT reservations. All Group tours must be cancelled no less than 30 days prior to arrival. 
