Four Seasons Resort and Residences Whistler reserves the right to implement a mandatory daily or per stay Resort Fee and/or Portage Charges for the 2015/16 contractual period. We will advise of such charges via email as well as the applicable costs subject to finalization. These charges will be applied to new bookings only.

CONDITIONS

1. CURRENCY

All rates in this Agreement are quoted in Canadian Dollars (CAD\$).

2. TAX

In the event of tax alterations by the government, the Resort reserves the absolute right to collect the revised tax without prior notice.

3. CONDITIONS IN RESPECT OF RATES

- a. Rates are not valid for incentives, meetings and special interest groups of 10 or more on any given night.
- b. The Resort reserves the right to charge the appropriate rates for reservations over and above the contracted room allocation.
- c. Contracted rates are applicable on the Operator's company account, only. Should the guest be paying on his/her own account regular published rack rates will be applied.
- d. Contracted rates are applicable only for brochure "packages" to include airport to resort transfers, accommodation, activities and, if applicable, airfare. These rates cannot be published as "room only" rates. Net rates must not be exposed in tariff listings or to source market operators. In the event net rates are not bundled, or if the resort finds these rates published on any channel, the resort reserves the right to terminate this agreement.

4. BEDDING

The pull out sofa bed in the guest room is considered an extra bed and will be used as bedding for the additional person in the room. Rooms with pull out sofa beds cannot accommodate a roll away bed. Each room carries a maximum occupancy of adults and children per room. All guestrooms are able to accommodate one baby crib, for infants.

5. RESERVATIONS

Direct reservations made by Guest or Travel Agents will not be accepted by the Resort at the contract rates stated herewith. The Operator shall direct all reservations to the Reservations Department of the Resort via facsimile or e-mail with complete details.

Subject to availability of the facilities required, the Resort shall accept and confirm the reservations in writing and notify the Operator within 48 hours or receiving correspondence. **Reservations shall not be binding upon the Resort until such acceptance and confirmation is issued.**

6. PARKING

Overnight Valet parking charges have been established at *\$39.00 per car, per night plus 5% GST. **Rates are subject to change

7. CHECK-IN / CHECK-OUT

Check-in is at 4:00 pm and check-out is at 11:00am.

8. DAY USE RATES / LATE CHECK-OUT

12:00 noon to 6:00 pm	-	50% of contracted rate
Beyond 6:00 pm	-	100% of contracted rate

Note:

Day Use and room change is subject to availability and confirmation by the Resort. The Day Use rates are net of taxes. To guarantee accommodation for guests with late flights and especially during the Festive Season, it is highly recommended to book an additional night upon reservation.

9. VOUCHERS/CREDIT

If the operator uses vouchers, please provide us with a sample. The Resort shall be entitled to invoice the Operator for such amounts as are supported by official vouchers or faxes issued by the Operator, without the necessity to produce the guests' acknowledgment.

10. PAYMENTS

- The services payable by the Operator shall be those specified in the reservation document forwarded to the resort.
- Unless otherwise instructed in writing by the Operator, the Guest(s) shall be responsible for payment of all incidental charges incurred during the stay to be settled upon check out.
- The Operator will prepay all bookings 30 days prior to the guests' arrival date, unless billing arrangements have been made. To apply for direct billing you must apply for credit directly with the hotel.
- Payment may be made by Company cheque or Wire Transfer. Bank account details to be provided upon request.

Please note, if billing privileges have been granted, all cancellation policies outlined above will still apply

11. CANCELLATION POLICY

In case of cancellation, a written notice of cancellation must be received by the Resort on or before the release/cut-off period as stated in this Agreement.

A unique cancellation # will be provided by the Resort The Operator is required to produce this # in case of dispute of cancellation. Cancellations will be considered incomplete without a cancellation #.

In the event such written notice is not received within the time limit stated, the Resort reserves the right to charge as above as laid out in hotel cancellation and deposit policy.

12. NO SHOW

Non-arrivals will be subject to the same charge as late cancellations: 100% of the room rate for the whole period of the reservation.

13. RENOVATION / UPGRADING

In order to keep the Resort in good condition, the Resort reserves the right to carry out repairs, renovation or upgrade / preventive maintenance programs as it may deem fit. The decision to renovate / upgrade shall be made by the Resort at its absolute discretion, but prior notice of commencement of any major renovation work on a prolonged basis that may affect guests comfort will be given to the Operator.

14. BROCHURE INCLUSION/ PARTICIPATION

The Operator will feature the Resort prominently in its programme(s) and brochure(s) as a “Deluxe Resort” or “Luxury Resort” and will include colored photograph(s). The brochure copy must be reviewed at proof stage and approved by the resort before printing or listing on the Internet. Please be sure to return a sample brochure with the signed agreement.

15. INTERNET SALES

The Operator may not use the Internet as a medium of advertising/distribution without the express written consent of the Resort. The Operators may not sell room only, unbundled rates to a 3rd party who uses the Internet as a medium of advertising/distribution without express written consent.

The Resort may suspend or terminate this contract immediately if the Operator breaches this clause.

16. TRAINING

The Operator will provide the Resort the opportunity to conduct in-office training/presentation to their reservations staff at least once per calendar year.

17. CONFIDENTIALITY

All information contained in this contract is private and confidential and shall not be disclosed to a third party for any reason or purpose without the written agreement of the Resort. The Resort reserves the right to terminate this contract if this confidentiality clause is broken.

18. TERMINATION

Termination of the Agreement will occur following the below circumstances:

- a. If the Operator commits a breach of any of the terms and conditions of this Agreement.
- b. If the Operator enters into a bankruptcy of liquidation whether compulsorily or voluntarily (otherwise than for the purpose of amalgamation or reconstruction) or compounds with its or their creditors or takes or offers any similar action in consequence of debt or is served with notice of or relating to bankruptcy or liquidation proceedings or if execution is levied against any of the assets of the Operator.
- c. Upon any change in the composition or (in any case of a company) ownership of the Operator.
- d. Force Majeure.

If for any reason beyond the Resort or Operator's reasonable control, including but not limited to Strikes; labor disputes; acts, regulations or orders of governmental authorities; civil disorder, Disasters; acts of terrorism; acts of war; acts of God; fires; flood or other emergency conditions; any delay in necessary and essential repairs of the Resort; the Resort or the Operator is unable to perform its obligations under this Agreement; such non-performance is excused and such party may terminate this Agreement without further liability of any nature, upon return of the operator's deposit or payment. In no event shall Hotel or Operator be liable for consequential damages of any nature for any reason whatsoever.

- e. If the Operator distributes contract rates or sub-contracts to other agencies or tour operators.

If there is non-observance by the Operator of the terms and conditions as it applies to the rates in clauses 1-19.

19. GENERAL PROVISIONS

This Agreement shall be governed by and construed in accordance with the laws of Canada.

a. Authority to Sign.

If this Agreement is signed in the name of the Operator, the person(s) signing represents and warrants to the Resort that he/she has full authority to sign. Such Agreement and that in the event he/she is not so authorized, he/she will be personally liable for the faithful performance of the Agreement.

b. Entire Agreement.

This Agreement contains all of the understandings between the parties and may only be modified in writing signed by both parties.

20. MINIMUM PRODUCTION REQUIREMENTS

This agreement is based on a minimum yearly production of **50** room nights, booked and stayed January 1st 2014 – December 31st 2014. Failure to produce **50** room nights will warrant a review and may result in Four Seasons Resort Whistler declining to renew the agreement.

This offer is valid for **30 days** from the date of issue. These rates will take effect on February 1, 2013. Kindly acknowledge your acceptance of the TERMS AND CONDITIONS as stated above by signing and returning the attached duplicate copy of this Agreement along with three original samples of your hotel voucher within the specified period.

BLOCK ALLOCATION

- d. The Resort reserves the right to adjust room allocations with advance notice in the event of high occupancies.
