- Group/FIT Cancellations:** Group: Less than 30 days prior to arrival – Forfeit deposit

- Check-in/Check-out:** Check-in: 3:00pm or later / Check-out 11:00am or earlier
- Bus Parking:** Ample free bus parking in our level paved parking area
- Complimentary Meals:** Tour escort and driver will receive a complimentary meal with each group/tour meal booked for a minimum of 15 people. No changes accepted less than 48 hours prior to arrival.
- Room Damage:** The tour company/organizer is responsible for any and all damage to rooms by escort, driver and guests.
