Deposit and final payment funds will be converted to Canadian dollars based on the hotel's current rate of exchange at the time of receipt.

Cancellation Policy

In the event of a group and/or tour cancellation or room block reduction, the hotel is to be notified in writing 31 days prior to arrival or the following charges will apply:

- a) For rooms cancelled 30-15 days prior to arrival, 50% of the value of the contracted rooms
- b) For rooms cancelled 14-0 days prior to arrival, 100% of the value of the contracted rooms

Attrition

Right up until 48 hours prior to arrival, you may reduce the room block by up to 20% without penalty, by providing written notice to the Hotel. Anything over that amount will be subject to a cancellation charge of 1 nights' room and tax per cancelled room.

No Shows for hotel rooms

For no show, that is guests who without prior cancellation fail to arrive at the hotel, tour operators must reimburse the hotel's loss, up to a maximum of one night's accommodation.
