- GENERAL INFORMATION:** Check in is at 4PM. Check out is at 11 AM. There will be no exceptions unless the hotel is able to accommodate. All rates include a Full Hot Breakfast served from 6:30AM – 9:30AM. Rates are based on 2 Adults per room - \$10.00 per additional Adult to a maximum of 4 per room. No charge for additional youth (18 and under). Complimentary high speed internet service & parking. Recreation facilities include an indoor pool, 2 waterslides (5:00 pm-9:30 pm Friday & Saturday), Jacuzzi & fitness center. Waterslide height restriction is 4ft tall.
- GUEST ROOM BLOCK:** The Hotel will review the entire room block with contracted Group representative at 45 days prior to the group arrival. The Hotel reserves the right to reduce the total block, should the pick-up be substantially below the original room block at the time of review. The Hotel reserves the right to review and renegotiate the room rates if pick-up is lower than 90% of the original block. The Hotel reserves the right to renegotiate each time the block is decreased, (example, if only 80%, then 70%, etc. of guestrooms are picked up)
- The Hotel reserves the right to renegotiate the Group Room Accommodation Contract and/or rates if the Group's requirements change significantly after authorized signature is obtained. If confirmation has not been received by this date, the Hotel reserves the right to release the space held in this contract, for resale.
- CONFIRMATION OF RESERVATIONS:** Reservations must be confirmed by no later by agreed upon rate. Any reservations not confirmed at this time will be automatically released and may be resold by the Hotel. Any additional guest rooms will be provided on a space availability basis, at the regular published Hotel rates.
- CANCELLATION POLICY:** The whole group may be cancelled no later than two weeks prior to arrival. If the whole group wishes to cancel after this date, the cancellation fee will be equal to the room and tax for each room for one room night. Individual cancellations and modifications may be made up to 24 hours day before arrival (by 4pm).
