


### ADDITIONAL INFORMATION

- GENERAL INFORMATION:** Check in is at 4PM. Check out is at 11 AM. There will be no exceptions only unless the Hotel is able to accommodate. All rates include a Full Hot Breakfast served from 07:00 AM – 09:00 AM. Rates are based on two adults per room - \$10.00 per additional Adult to a maximum of 4 per room. No charge for additional Youth (18 and under). Complimentary high-speed internet service & parking. Recreation facilities include an indoor pool with two waterslides, (Times Vary based on time of year) , Jacuzzi and fitness center. Waterslide height restriction is 4ft tall.
- GUEST ROOM BLOCK:** The Hotel will review the entire room block with Contracted Group Representative at 45 days prior to the group arrival. The Hotel reserves the right to release remaining rooms at time and create any outstanding reservations based on availability. The Hotel reserves the right to renegotiate the rate and release the space held in this contract if pick-up is lower than 70% of the original block. The Hotel reserves the right to renegotiate the details in the Group Room Accommodation Contract if the group's requirements change significantly after authorized signature is obtained.
- CONFIRMATION OF RESERVATIONS:** Group reservations must be confirmed by 30 days prior to the Group arrival. Any reservations not confirmed at this time will be automatically released and may be resold by the Hotel. A rooming list is required by 14 days prior to the Group arrival. Any additional guest rooms will be provided on a space availability basis at the regular published Hotel rates.

4. CANCELLATION POLICY: The whole Group may be cancelled by 30 days prior to arrival. If the whole Group wishes to cancel after this date, the cancellation fee will be equal to the room and tax for each room for one room night. Individual cancellations and modifications may be made up to 24 hours day before arrival by 4 PM. We understand that there may be special cases, please just advise of any changes as soon as possible.
