


Lodging rate structure

Wholesale Net Rates are subject to the policies and procedures contained in this Agreement. Mont Tremblant Resort reserves the right to change rates at any time without notice, including without limitation, creating special rates or packages. For FIT rates, if you have an agreement with Marriott International, please refer to your contract with the banner.

Royalty

Please note that a Royalty fee, equivalent to 3.5% of the price advertised or payable for lodging, and a 3% of the listed or advertised price of goods and services offered in the establishments on the territory of Station Mont Tremblant, will be added to your invoice. This Royalty fee corresponds to the percentage of the contribution determined by the Tremblant Resort Association. This notice is in accordance with the "Règlement d'application de la Loi du consommateur" (Articles 91.6 and 91.7). The royalty fee allows the Tremblant Resort Association, a non-profit organization, to ensure that guests enjoy a truly unique and memorable experience, by offering top-notch entertainment, events and shows, the majority being free, as well as world-class services and facilities. Royalty fee may vary without prior notice.

Or if not accepted to the direct billing, all bookings will have to be prepaid.



The Tour Operators who want to have the **privilege of direct billing status**, Mont Tremblant Resort must make a credit re-view. To do so, Mont Tremblant Resort must receive a duly completed credit application at least thirty (30) days prior to first arrival. This application is subject to approval by our Credit Manager in his or her sole discretion.

- **In the event that credit is denied**, your booking will only be honoured on a prepaid basis.
- **Failure to pay invoices within thirty (30) days of receipt** will entail administration fees of 1.5% per month or 18% per year from date of invoice and the direct billing status could be compromised. In the case of disputed items, the Wholesaler agrees to pay the undisputed portion of the bill and, at that time, notify Mont Tremblant Resort in writing of the nature of the dispute.



- **If the request for direct billing is accepted**, the Wholesaler agrees to respect the first deposit conditions. The final payment of each group will be due upon receipt of the final invoice. FIT reservations will be due upon receipt of each invoice.
- **Failure to pay invoices within thirty (30) days of receipt** will entail administration fees of 1.5% per month or 18% per year from date of invoice and the direct billing status could be compromised. In the case of disputed items, the Wholesaler agrees to pay the undisputed portion of the bill and, at that time, notify Mont Tremblant Resort in writing of the nature of the dispute.
- **If the direct billing status is refused**, then the Wholesaler is on a prepay status and all deposit and final payment conditions apply before the arrival of each group or FIT guest.

The Wholesaler must pre-pay a minimum of seven (7) days prior to the arrival of each group or FIT guests.

- **A floating deposit can be used** to cover ski lift tickets, rental and snow school. Mont Tremblant Resort's accounting department operates on a seven-day billing cycle; therefore, if a deposit is provided, it must sufficiently cover the time required for invoicing and payment processing. Said deposit may be in the form of an irrevocable letter of credit, a cheque, or a wire transfer (minimum deposit: \$3,000.00 CDN).
- **All accounts working on a floating deposit basis** will be issued a final invoice to reconcile the account. Should there be any outstanding balances resulting from discrepancies or should the Wholesaler fail to respond and satisfactorily clear up any balance within five (5) working days, Mont Tremblant Resort will discontinue voucher acceptance. In addition, for all outstanding balances past thirty (30) days, a 1,5% per month administration fee will be charged and the account status for the following season or other bookings could be compromised.

Should the GROUP be cancelled more than thirty (30) days before arrival, the first deposit will be returned and will be deducted.





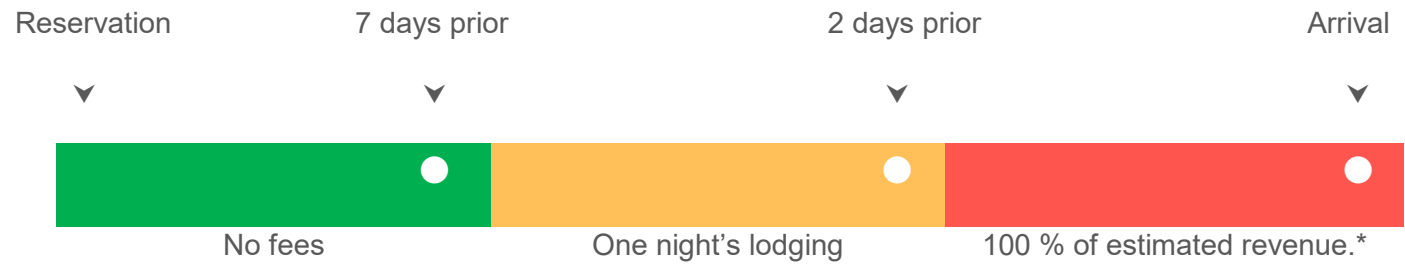

Upon cancellation or termination of this Agreement, the parties will instruct each other as to the manner in which copyrighted or copyrightable materials or other materials bearing the parties marks, names or logos shall be disposed.

GROUP & FIT net rates are available to licensed Clients who print a brochure, a catalogue, a website, an E-brochure or other promotional tools. 



- For the purpose of this Agreement, a GROUP booking is defined as ten (10) rooms or more or at least twenty (20) people travelling together.
- FIT booking is defined as nine (9) rooms or less or nineteen (19) people or fewer travelling together.
- “Mont Tremblant Resort” or “us” means Mont Tremblant Resorts and Company, LP.
- “Wholesaler” or “you” means the tour operator or wholesaler identified on the cover page of this Agreement.

GENERAL POLICIES

No amendment, alteration, modification or addition to this Agreement will be valid or binding unless expressed in writing and signed by both the parties to this Agreement. The terms of this Agreement shall also govern any Annexe or Specific Contract between the Wholesaler and Mont Tremblant Resort. In the event of a conflict between the terms of this Agreement and those of any Annexe or Specific Contract between the Wholesaler and Mont Tremblant Resort, the terms of the Annexe or Specific Contract shall prevail.

It is agreed that Mont Tremblant Resort is not to be held responsible for any lost or damaged equipment, displays or all other equipment not owned by them and being utilised for your meetings. PROHIBITION: Alcohol Consumption in the public areas of Tremblant Pedestrian Village. You are responsible to advise the persons in your group that Alcohol Consumption in public areas of the pedestrian village including hotel pools areas & hot tubs is strictly prohibited. The organiser or exhibitor will need to supply proof of insurance for all material on display and we recommend hiring security guards. The Wholesaler accepts full responsibilities for damages caused by himself and / or members of his group during the entire period of his stay in our establishment.

FORCE MAJEURE EVENT

Except as otherwise provided in this Section, failure of either party hereto to perform any of its obligations under this Agreement shall be suspended to the extent such failure is caused by a Force Majeure Event affecting such party, and such failure will not be deemed a breach (partial or otherwise) of this Agreement or subject the affected party to any liability in connection therewith, provided that (i) the affected party gives prompt notice thereof to the other party, (ii) the affected party acts with reasonable diligence to remedy the situation, to the extent practicable, and (iii) the suspension shall be of no greater scope and of no longer duration than that required by the Force Majeure Event.

As used herein, a “Force Majeure Event” is an event or occurrence beyond the reasonable control of the affected party and without its fault or negligence, and which could not have been avoided or overcome by due diligence and use of reasonable efforts. A Force Majeure Event may include, by way of example only, flood, tornado, hurricane, other unusually severe storm, lightning, earthquake, explosion, fire, riot, acts of the public enemy, civil disturbance, natural disasters, impact of war or mobilization, sabotage, power outages or actions by any governmental authority (whether valid or invalid), including court order and other similar types of events. Changes in general economic conditions such as inflation, interest rates, economic downturn or other factors of general application, or events that merely render performance more difficult or expensive, do not constitute a Force Majeure Event. An epidemic or pandemic constitutes a Force Majeure Event only to the extent that either (1) a government authority with jurisdiction over the Hotel has issued a formal notice or warning to avoid non-essential travel during the dates in question to areas within 60 miles (100 kilometers) of the Hotel, or (2) a government authority with jurisdiction over the guest has issued a mandatory quarantine, shelter-at-home order or other such decree that legally prohibits the guest from traveling to the Hotel.

If a Force Majeure Event limits but does not substantially eliminate the affected party’s ability to fulfill the booking(s) under this Agreement, the booking will proceed on a limited basis and the parties will work in good faith to modify the scope and cost of the booking accordingly. If a Force Majeure Event substantially eliminates the affected party’s ability to fulfill the booking(s) under this Agreement, including where the Hotel has decided to close to the public, the Hotel may postpone the booking(s), in which case the Group will receive a credit for all amounts paid and the parties will work in good faith to reschedule the booking(s). Should a reasonable number of alternative dates be available, and the Group is still not in a position to reschedule, the Group will be reimbursed.
