### Room Allotments

Rooms are based on single or double occupancy; additional occupants up to a maximum of 4 people can be accommodated at an additional cost of \$20 per person. All rooms are non-smoking. We appreciate your submission of bed-type request and every effort will be made to accommodate these requests, based on availability.

### Tariff/Brochure Publication

In compliance with laws on packaged travel, St. Eugene Golf Resort & Casino has a responsibility to consumers to ensure that the description of our product and service is accurate in all material respects. To comply with this directive, we request that you submit all printed descriptive and/or advertising copy pertaining to St. Eugene Golf Resort & Casino to us for review, no later than 30 days prior to publication. We request that the hotel be featured with a hotel photograph whenever possible, with the name featured with our corporate identification, e.g. St. Eugene Golf Resort Casino.

### Check-In/Check-Out Time

Check-In: 4:00 pm (MST); Check-Out: 11:00 am (MST). Should a guest/group plan to arrive at the hotel prior to 4:00 pm, please include this information on the rooming list or at the time of booking. Every effort will be made to accommodate early arrivals based on availability; however, room type cannot be guaranteed.

### Wholesale Agreements

### Taxes

For bus tours, a complimentary room will be provided for the bus driver with a minimum of 20 paid guest rooms per night.

#### Luggage Handling

The St. Eugene Mission Resort standard policy for luggage handling is \$3.25 plus applicable taxes, per bag, round trip.

#### Family Plan

Children 16 years of age and under may stay at no extra charge in their parent's room (excluding meals).

#### Incidental Charges

As we do not have the addresses of the tour patrons, it is the policy of St. Eugene Golf Resort Casino that the tour escort assists in the collection of incidental charges prior to departure. Charges not collected will be the responsibility of the tour operator. Guests will be required to leave a credit card imprint with the Front Desk before signing privileges on incidentals will be extended – unless a master account is established, and all charges are guaranteed by the Tour Operator.

Gratuities/service charges and taxes are applicable to all group reservations. Tour operators will be responsible for the payment of gratuities and should include all charges when costing their packages.

#### Motor Coach Parking

Motor coach parking is located on site and is complimentary.

#### Pledge Relocate Policy

In the event the hotel does not honor all guaranteed reservations to your tour group, then the hotel shall, at its own expense, secure comparable accommodations and provide, at its own expense, transportation to and from such accommodation. This shall apply to each day (two nights maximum) during which rooms are not provided and guests must be housed elsewhere.

#### Payment Procedure

**BC Golf Guide** is responsible for payment of bedroom accommodation, meals, gratuities and/or baggage (where applicable) and taxes. A major credit card is required to secure any group booking. See cancellations policy below.

#### Foreign Currency

Deposit and final payment funds will be converted to Canadian dollars based on the hotel's current rate of exchange at the time of receipt.

#### Cancellation Policy

In the event of a group and/or tour cancellation or room block reduction, the hotel is to be notified in writing 31 days prior to arrival or the following charges will apply:

- a) For rooms cancelled 30-15 days prior to arrival, 50% of the value of the contracted rooms
- b) For rooms cancelled 14-0 days prior to arrival, 100% of the value of the contracted rooms

#### Attrition

Right up until 48 hours prior to arrival, **BC Golf Guide** may reduce their room block by up to 20% without penalty, by providing written notice to the Hotel. Anything over that amount will be subject to a cancellation charge of 1 nights' room and tax per cancelled room.
