Direct Bill Scenario:


Invoices are due and payable upon receipt and must be paid in full within 15 days to receive net rate discounts. If an invoice is not paid within 15 days accommodation will no longer accept lodging vouchers or extend credit to the supplier. Any and all additional bookings by the supplier will be canceled without receiving payment in full upon notification of a delinquent account. In the event that payment is not made within 30 days after receipt of the original statement, it is agreed that the a LATE PAYMENT CHARGE will be applied, at the rate of 1.5% PER MONTH (ANNUAL RATE 18%), on the unpaid balance, and reasonable costs of collection, including attorney fees.
