

## TOUR POLICIES

Extra Adult Sharing	Add \$30.00 for a third adult. Children under 18 stay free with existing bedding, when sharing with an adult. Maximum occupancy in room is 4 people.
Baggage Handling	Mandatory, for groups of 10 rooms or more & charged at \$5.00 per person, round trip, plus 5% GST
Complimentary Room	One complimentary room will be provided for every 20 rooms paid per night, to be used during the period outlined in contract.
Blackout Dates	<b>The following dates are already booked at the hotel due to large conferences or events: January 13-16, February 18- 20, April 7,8,9,22, 23, 24,25, May 20,21,22, August 5,7, September 2,3,4 October 7,8,9.</b>
Breakfast	Hot Buffet breakfast is \$28.00++
Payment	Payment for groups and FIT will be direct billed to the master account established at the hotel.
Cancellation Policy	In case of cancellation of entire group less than 30 days prior to arrival, 50% of the group's first night room and taxes will be charged if rooms

	cannot be resold. FIT may cancel up to 48 hours prior to arrival without penalty.
Rooming List	Required 30 days prior to tour arrival date.
Check-in Time	4:00 p.m.
Check-out Time	11:00 a.m.
Luggage Storage	Provided free of charge for early arrivals or late departures.
Impossibility of Performance	It is expressly agreed that each party shall be relieved of its obligations under this Agreement in the event and to the extent the performance of this agreement is delayed or prevented by any cause reasonably beyond its control, including, without limitation, acts of God, and acts or orders of government authorities including travel restrictions, or by fire, flood, or explosion, pandemic, sale of the Hotel, necessary and essential construction, disruption of utility services, arrest or seizure under legal process, strike, lockout or work stoppage or other restraint of labour either partial or general, from whatever cause. If and when the occurrence or condition which delayed or prevented such performance shall cease and be removed, it shall be the obligation of the Hotel or the Group, as the case may be, without further delay to commence the correction of such performance or confirm the correction thereof.
